## **How is it assessed?**

You will be assessed through a three-hour "open-book" exam which will be in the essay type format. The passing score for this exam is 70%.

## **Do I need any prior qualifications to start this course?**

There are no formal entry requirements to join this course. However, it is recommended that you have a fundamental understanding of ISO 14001 and comprehensive knowledge of audit principles.

## **I completed and received my certification, what happens next?**

Upon successful completion of the “PECB Certified ISO 14001 Lead Auditor” exam, you can apply for “PECB Certified ISO 14001 Lead Auditor” credential. Please contact us for more information.
